Highly refined mineral oil and Additives.

**3. HAZARDS IDENTIFICATION**

<b>Emergency Overview</b>	
<b>Appearance and Odour</b>	: Amber. Liquid at room temperature. Slight hydrocarbon.
<b>Health Hazards</b>	: Not classified as dangerous for supply or conveyance.
<b>Safety Hazards</b>	: Not classified as flammable but will burn.
<b>Environmental Hazards</b>	: Not classified as dangerous for the environment.

<b>Health Hazards</b>	: Not expected to be a health hazard when used under normal conditions.
<b>Health Hazards Inhalation</b>	: Under normal conditions of use, this is not expected to be a primary route of exposure.

**4. FIRST AID MEASURES**

- General Information** : Not expected to be a health hazard when used under normal conditions.
- Inhalation** : No treatment necessary under normal conditions of use. If symptoms persist, obtain medical advice.

**5. FIRE FIGHTING MEASURES**

Clear fire area of all non-emergency personnel.

- Upper / lower Flammability or Explosion limits** : Typical 1 - 10 %(V)
- Auto ignition temperature** : > 320 °C / 608 °F
- Specific Hazards** : Hazardous combustion products may include: A complex mixture of airborne solid and liquid particulates and gases (smoke). Carbon monoxide. Unidentified organic and inorganic compounds.
- Suitable Extinguishing Media** : Foam, water spray or fog. Dry chemical powder, carbon dioxide, sand or earth may be used for small fires only.

**6. ACCIDENTAL RELEASE MEASURES**

- Clean Up Methods** : Slippery when spilt. Avoid accidents, clean up immediately. Prevent from spreading by making a barrier with sand, earth or other containment material. Reclaim liquid directly or in an

**7. HANDLING AND STORAGE**

- General Precautions** : Use local exhaust ventilation if there is risk of inhalation of vapours, mists or aerosols. Properly dispose of any contaminated rags or cleaning materials in order to prevent fires. Use the information in this data sheet as input to a risk assessment of local circumstances to help determine appropriate controls for safe handling, storage and disposal of this material.
- Handling** : Avoid prolonged or repeated contact with skin. Avoid inhaling vapour and/or mists. When handling product in drums, safety footwear should be worn and proper handling equipment should be used.

- Exposure Controls** : The level of protection and types of controls necessary will vary depending upon potential exposure conditions.
