**2. COMPOSITION/INFORMATION ON INGREDIENTS**

Zinc alkyl dithiophosphate CAS 68649-42-3  
Highly refined mineral oils, water and additives.  
The highly refined mineral oil contains <3% (w/w) DMSO-extract, according to IP346.

**3. HAZARDS IDENTIFICATION**

<b>Emergency Overview</b>	
<b>Appearance and Odour</b>	: Amber. Liquid at room temperature. Slight hydrocarbon.
<b>Health Hazards</b>	: Not classified as dangerous for supply or conveyance.
<b>Safety Hazards</b>	: Not classified as flammable but will burn.
<b>Environmental Hazards</b>	: Not classified as dangerous for the environment.

**Health Hazards** : Not expected to be a health hazard when used under normal conditions.

**Health Hazards**

**Inhalation** : Slightly irritating to respiratory system.

**Skin Contact** : Prolonged or repeated skin contact without proper cleaning can clog the pores of the skin resulting in disorders such as oil acne/folliculitis.

**Eye Contact** : May cause slight irritation to eyes.

**Ingestion** : Low toxicity if swallowed.

**4. FIRST AID MEASURES**

<b>General Information</b>	:	In general no treatment is necessary, however, obtain medical advice.

**7. HANDLING AND STORAGE**

- General Precautions** : Use local exhaust ventilation if there is risk of inhalation of vapours, mists or aerosols. Properly dispose of any contaminated rags or cleaning materials in order to prevent fires. Use the information in this data sheet as input to a risk assessment of local circumstances to help determine appropriate controls for safe handling, storage and disposal of this material.

- Exposure Controls** : The level of protection and types of controls necessary will vary depending upon potential exposure conditions. **Stability** : Stable.

**Conditions to Avoid** : Extremes of temperature and direct sunlight.

**Materials to Avoid** : Strong oxidizing agents. DO NOT add nitrites or any nitrosating agents. May react with amines and form nitrosamines which cause cancer in animal tests.

Highly refined mineral oils are not classified as carcinogenic by the International Agency for Research on Cancer (IARC). Other components are not known to be associated with carcinogenic effects.

**Reproductive and Developmental Toxicity** : Not expected to be a hazard.

**Additional Information** : Used oils may contain harmful impurities that have accumulated during use. The concentration of such impurities will depend on use and they may present risks to health and the environment on disposal. ALL used oil should be handled with caution and skin contact avoided as far as possible. Properly manage used fluids. Used metalworking fluids may accumulate harmful bacteria. **12. ECOLOGICAL INFORMATION**

Ecotoxicological data have not been determined specifically for this product. Information given is based on a knowledge of the components and the ecotoxicology of similar products.

- Acute Toxicity** : Poorly soluble mixture. May cause physical fouling of aquatic organisms. Expected to be practically non toxic: LL/EL/IL50 > 100 mg/l (to aquatic organisms) (LL/EL50 expressed as the nominal amount of product required to prepare aqueous test extract). Mineral oil is not expected to cause any chronic effects to aquatic organisms at concentrations less than 1 mg/l.
